## **Sanctuary for Families Marathon Team: Terms and Conditions - Please Read Carefully & Sign**

**Fundraising Commitment:** A \$3,000 minimum fundraising commitment is required to join the Sanctuary for Families Marathon Team and receive an invitational entry for the 2020 TCS New York City Marathon which will take place on Sunday, November 1, 2020.

Valid credit card information must be included with your application to apply for placement on the Sanctuary for Families Marathon Team. In the event that you do not meet the minimum donation requirement by **Friday, November 6, 2020** at 5:00 pm, Sanctuary for Families reserves the right to charge the balance owed to your credit card.

We strongly suggest that you raise at least half of the funds by **Friday, November 6, 2020**. If you have not raised half of the funds by that date, Sanctuary for Families may contact you to discuss your fundraising plan.

### **Cancellation Policy:**

If for some unforeseen reason you need to withdraw from the Sanctuary for Families Marathon Team, we ask that you abide by the following terms:

- If you withdraw after **before Tuesday, August 1, 2020**, you are responsible for a **\$75.00 fee** incurred to Sanctuary for the replacement of the marathon spot.
- If you withdraw anytime on or after **Tuesday, August 1, 2020**, you are responsible for raising the **\$3,000 minimum** fundraising commitment, even if for any reason, including injury, you are unable to run in the marathon.

You must contact Hannah Patridge at Sanctuary for Families, in writing, on or before the cancellation dates. **\* Please note: Donations raised and received by Sanctuary for Families will not be refunded, even if you cancel before Tuesday, August 1, 2020.**

**Registration and Fee:** Sanctuary for Families will inform you of the details of registration after your TCS New York City Marathon application is accepted. **The TCS New York City Marathon charges a race entry fee that does not count toward your fundraising minimum.** This fee will be collected at a later date by the New York Road Runners. You should NOT contact the New York Road Runners directly to secure your bib number.

**Matching Gift Policy:** Many companies match employees' charitable contributions. We encourage you to check with your employer to see if your company has a matching gift program, and ask your donors if their employers match gifts. It is your responsibility to contact the matching company to ensure the matching gift form will be issued before **Friday, October 30, 2020**. If Sanctuary for Families does not receive the matching gift form prior to **Friday, October 30, 2020** the match cannot count toward your minimum.

### **Liability Waiver and Release Form and Contribution Agreement:**

- I know that training for and participating in the TCS New York City Marathon is a potentially hazardous activity. I understand that I should not enter and run unless I am medically able to do so and properly trained. I am voluntarily entering, and I assume all risks associated with training for and running in this event, including injuries during training or racing; falls, spills, contact with vehicles or other participants, the effects of weather, traffic and course conditions, and all other conditions, foreseen or unforeseen, all such risks being understood and accepted by me.

• Having read and understood this waiver, and in consideration of the acceptance by Sanctuary for Families of me as a member of the Sanctuary for Families Marathon Team, I, for myself and my legal representatives, successors, heirs, assigns, executors and administrators, do hereby waive and release Sanctuary for Families and its officers, directors, agents, employees and other representatives from all present and future claims and liabilities of any kind, known or unknown, foreseen or unforeseen, arising out of or in any way connected with my training for or participation in this event.

• I hereby grant permission to Sanctuary for Families to use my name and/or photograph, voice or other likeness in broadcast, telecast, print or any other account of this event for any legitimate purpose.

• I agree to abide by the rules of the TCS New York City Marathon as stated in all official race information.

• I agree to collect a minimum of \$3,000 for Sanctuary for Families by **Friday, November 8, 2019**. If I have not reached the minimum in sponsorship by that date, I will be personally responsible for the balance owed.

• I understand that if I cancel **before Tuesday, August 1, 2020**, Sanctuary for Families reserves the right to bill a cancellation fee of \$75.00 to my credit card.

• I understand that if I cancel on or after **Tuesday, August 1, 2020**, Sanctuary for Families reserves the right to bill the balance of my \$3,000 fundraising obligation to my credit card.

• I agree that if the race cannot be held for any unforeseen circumstance, any funds raised by me will not be refunded.
