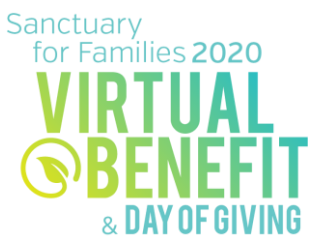

Annually, Sanctuary empowers more than 10,000 adults and children to move from fear and abuse to safety and stability, transforming lives through legal and clinical services, economic empowerment, and shelter.

**CHANGEMAKER / \$100,000**

Help immigrant gender violence survivors secure and maintain lawful immigration status and obtain U.S. citizenship; immigration status is often a barrier to survivors seeking to escape abusive homes.

**ALLY / \$2,500**

Contribute to Sanctuary's Anti-trafficking Initiative which provides more than 300 sex trafficking survivors with holistic legal, clinical, case management, shelter, and other direct services annually.

**SUPPORTER / \$1,000**

Secure a week of shelter for a family fleeing abuse. Sanctuary houses up to 200 adults and children every night, offering a safe and nurturing space to heal and rebuild lives free from violence.

**INNOVATOR / \$500**

Ensure that families moving from shelter into permanent housing are provided food, household items, and clothing to ease their transition.

**PATRON / \$250**

Give the freedom of a monthly MetroCard and groceries to a client in need.
